1.	What is the justification for the change(s) requested? You need a 3.0 GPA at the end of your second year to be admitted to the business major. Our records indicate that a large majority of students with a GPA between 2.5-2.75 after their first year were not able to raise their GPA enough to be admitted to the business major and were delaying their progress at TCU by remaining a pre-business major in their second year.
	These students would still be eligible to apply to the Neeley school as internal transfers if their GPAs improved. They would just apply through our internal transfer process instead of as a prebusiness major.
