1. What is the justification for the change(s) requested?

The present requirement of 6 credit hours of Studio Art courses for the Art History major exceeds the recommendation of the National Association of Art and Design (NASAD), which suggests one course in Studio Art for the Art History major. Also, the Art History program conducted an external review in Fall 2019, and one of the recommendations of the reviewers was to lower the Studio Art requirement so as to make the Art History major more accessible for students.

The present requirement of only 10000-level Studio Art courses has been limiting for students. By expanding this requirement to any 10000-level or 20000-level Studio Art course, students will have more choices in course offerings.

The new language to describe the types of courses art history majors should take better reflects the chronological, geographical, and cultural diversity of courses we want students to take for the major.
