The BS with a major in journalism requires 124 hours with 39 hours of journalism, including JOUR 10113, JOUR 10203, JOUR 10303, JOUR 20003, JOUR 30204, JOUR 40523 and JOUR 40983. Students must take at least one class from the following: JOUR 40203, JOUR 40453, JOUR 40463, JOUR 40483, JOUR 40643, or JOUR 40820, meaning all journalism majors must have a minimum of one upper-level reporting course. Also, students must take at least one class from the following: JOUR 30853, JOUR 40443, JOUR 40553, JOUR 40563, JOUR 40573, JOUR 40613, JOUR 40813, or JOUR 40993. meaning all journalism majors must have a minimum of one seminar course. Eleven hours of journalism electives complete the degree requirements.

A minor is required. Additionally, students may pursue a specialty by fulfilling requirements for a certificate in broadcast journalism.

The current B.S. in News and Media Studies is designed for students who do not wish to seek a career in professional journalism but should be proficient in journalism skills in order to work at institutions outside newsrooms. However, the name "News and Media Studies" does not adequately reflect and address the academic intentions and professional aspirations of students currently enrolled in the program, and is also less focused on skills development. The new BS in Journalism would certify students as having gone through a journalism program, provide them the opportunity take more upper-level skills courses needed for gainful employment in non-newsroom environment (in lieu of the language requirement for a BA program), offer them an opportunity to benefit from the hands-on experience in our department's students media, and increase enrollment for the department, while not stretching our current faculty capacity.
