1. What is the justification for the change(s) requested?

Program faculty believe these changes would result in a more meaningful experience for YAES majors.

- 1) Faculty teaching EDUC 20003 have shared that course content is pertinent to those seeking teacher certification. Since the YAES program does not lead to teacher certification, and does not attract students who are interested in pursuing teacher certification, the course is not needed/relevant as a degree requirement. Instead, it is more relevant as a degree elective.
- 2) In addition, content covered in EDUC 41113/55113 is more relevant than EDUC 20003 to career aspirations of YAES majors, so it is being proposed as a degree requirement.
- 3) The addition of EDUC 30103 provides YAES majors who are specifically interested in the development of teenage youth with a more specialized option that can be taken instead of EDUC 30143, which is a more generalized human development course spanning birth through young adulthood.
- 4) EDUC 40113, EDUC 30213, EDUC 40123, and EDUC 55960 are all new courses developed in 2020 which align with the academic interests and career aspirations of YAES majors.
- 5) "C or better" should be changed to "C- or better" as faculty have academic freedom to opt for plus/minus grading; thus, a "C- or better" helps to ensure equity for students
- 6) Changing transfer GPA from 2.75 to 2.50 has been requested by TCU Admissions as this better aligns with other colleges and universities admission practices; having a higher GPA requirement for transfer students may falsely assume that TCU courses are more challenging than all other universities.
