1. What is the justification for the change(s) requested?

The majority of students applying to the two accredited dietetics programs, the Combined BS/MS in Dietetics (CDP) and the Didactic Program in Dietetics (DPD), are NUTR majors.

By requiring that the courses be taken at TCU, transfer students are prevented from meeting the prerequisite courses to begin the CDP without enrolling in these courses first.

This will allow transfer students to transition into the NTDT Department more smoothly.

Additionally, we are submitting requested changes to allow these courses for all of the majors impacted in our Department to maintain consistency of expectation regarding the ability to transfer these courses.
