All majors need to be included for a C- in major coursework not just two of the majors as stated presently. 2) The GPA requirements for PEAL/PESC/BSAT majors need to match the college of education accreditation requirements for teaching and the athletic training accreditation requirements. This change is aligning these majors with accreditation standards.
